Scholarship---- High Level Postgraduate Program

(Type B)

Program Introduction

The Chinese Government Scholarship Program for High Level Postgraduate is designed to select international students with excellent academic backgrounds, professional abilities and potential for future development to study for master's and doctoral degrees in CUC.

Program Content

- (1) Admission Levels: Master's, Doctorate; International students admitted for the fall semester of 2024.
- (2) Selection Mechanism: Individual application, university recommendation, expert review, selective admission. CUC recommends candidates to the China Scholarship Council. The final admission results are based on the expert review conducted by the China Scholarship Council.
 - (3) Recommended Quota: 20 positions.

Scholarship Coverage

- Tuition fees;
- Free university dormitory or accommodation subsidy;
- •Stipend:

Master's students/general scholars: CNY 3,000 per month; PhD students/senior scholars: CNY 3,500 per month.

• Comprehensive medical insurance:

CNY 800 per person per year;

Eligibility

- 1. Applicants must be non-Chinese citizens and in good physical and mental health.
 - 2. Age, education and language requirements:
- (1) Applicants for master's degree should have a bachelor's degree or equivalent, have excellent academic performance and be no older than 35 years old;
- (2) Applicants for PhD degree should have a master's degree or equivalent, have excellent academic performance, and be no older than 40 years old;
- (3) Applicants for master's degree or PhD degree with Chinese as the language of teaching in their majors shall have a Chinese language proficiency of at least 180 scores in HSK Level 6 (with a score of at least 60 in a single subject), which is only valid within two years;
- (4) Applicants for master's and PhD degree programs with English as the major language of instruction must have an English language proficiency of not less than 6.5 score in IELTS, not less than 85 score in TOEFL (IBT), and not less than 750 score in TOEIC, which are only valid within two years.

*If the applicant is a recent graduate, they must ensure that they obtain the relevant graduation or degree certificate before the commencement of the academic year; otherwise, the admission qualification will be deemed invalid.

*Applicants are not allowed to choose their native language or cultural studies related to their native language as their research direction. (For example, if the applicant's native language is English, he/she cannot apply for the major of "English" or "English Language and Literature".)

Application Documents

- 1. Application Form for Chinese Government Scholarship (in Chinese or English);
- 2. Photocopy of passport information page, passport must be an ordinary passport valid for at least one year (applicants who have already studied in China should also

provide a scanned copy of their visa or residence permit);

3. Applicants for Chinese-taught programs are required to provide a scanned copy of the original HSK-6 certificate and transcripts which at least reach180 scores in HSK Level 6 (with a score of at least 60 in a single subject). For applicants of English-taught programswhose mother language is not English and whose previous study and work experience do not prove the appropriate level of English proficiency, a scanned copy of the original transcript of the appropriate English proficiency test is required. The IELTS score should not be less than 6.5, TOEFL (IBT) score should not be less than 750.

4. Highest academic qualifications and degree certificates in English or Chinese (prospective diploma winners can first provide proof of expected graduation), which must be original or notarised, either in Chinese or English; if the originals are not in Chinese or English, notarised translations in Chinese or English are required (the original of the highest academic qualifications and degree certificates must be presented at the time of enrolment);

5.Academic transcripts (from the undergraduate program onwards). Copies of academic records from first to last semester during the undergraduate, graduate (if any), and PhD programs (if any) shall be provided. These transcripts shall be issued and sealed by the attending university's academic affairs office, graduate school, or student management department. They can be in Chinese or English, but must be attached with notarized English translations if they are in foreign languages other than English;

6.A Curriculum Vitae (CV), written in the language of the program to which the applicant is applying and limited to one page;

7.A research proposal. Applicants for Master's degrees taught in Chinese should submit a research proposal of not less than 2000 words, and applicants for Master's degrees taught in English should submit a research proposal of not less than 1000 words. Applicants for PhD degree should submit a research proposal of not less than 3000 words for Chinese taught programs and not less than 1500 words for English taught programs;

8. Recommendation letters. Two letters of recommendation (written only in

Chinese or English) from professors or associate professors shall be submitted

(scanned copy of the original document);

9. Copies of published academic papers, awards or other research results (if any);

10. Collection of Personal Works. Applicants applying for art, design and other

majors can upload their personal works (e.g. images, paintings, etc.) through the

"Works/Other Supporting Materials" in the "Chinese Government Scholarships for

Studying in China Management Information System", or contact the University to

provide them in other ways;

11. A photocopy of the Foreigner Physical Examination Form completed in

English (the original copy shall be kept by the applicant). The form is designed by the

Chinese quarantine authority and can be obtained from the dispatching authority. The

physical examinations must cover all the items listed in the Foreigner Physical

Examination Form. Incomplete records or those without the signature of the attending

physician, the official stamp of the hospital, or a sealed photograph of the applicants

are invalid. Please select the appropriate time to take a physical examination as the

result is valid for only 6 months;

12. Non-criminal record report. The applicant shall submit a valid certificate of

Non-Criminal Record issued by the local public security authority, usually issued

within 6 months prior to the submission date of the application;

Application Procedures

1. Please email the above application materials to guoyuexin@cuc.edu.cn; after

submitting the application, applicants will receive feedback on the initial review within

- 3 working days (except legal holidays); if you receive notification about additional materials, please submit the relevant materials before March 10, 2024. Late submission of supplementary materials will not be accepted.
- 2. By March 15, 2024, all applicants who have passed the preliminary assessment will be arranged for interviews by the relevant professional teachers, and will be informed of the specific time and manner of interviews by email. Interview results are expected to be sent by email before March 20, 2024, and students who pass the interview will receive a Pre-Admission Letter from Communication University of China.
- 3. For those who have received the Pre-Admission Letter, please be sure to log on to the online application system of the China Scholarship Council at http://studyinchina.csc.edu.cn/ before March 25, 2024 to supplement the Pre-Admission Letter (please fill in "10033" for the accepting organization number and "B" for the type of study abroad program).
- 4. Please make sure that the materials submitted to guoyuexin@cuc.edu.cn are the same as those on http://studyinchina.csc.edu.cn/. The China Scholarship Council (CSC) will organize experts to conduct the final examination of the applicants recommended by CUC, and the application materials will be used as an important basis for the CSC to determine the final results of the admissions process (not every student receives the Pre-Admission Letter by CUC will be awarded a scholarship).

Reminder:

- ◆ Uploaded supporting documents must be clear, authentic and valid.Applicants are recommended to use a professional device to scan the relevant documents. Applicants shall bear the consequences caused by unclear or unidentifiable uploaded materials.
- ◆ Scholarship recipients are required to participate in the annual assessment of the scholarship. Failure to participate in the assessment or failure to pass the assessment will result in suspension or cancellation of their eligibility for the scholarship.
- ◆ Chinese government scholarship students are not allowed to enjoy the financial

support of other scholarships (except all kinds of one-time incentive payments)

established by Chinese governments at all levels and the admitted institutions in China

at the same time; once discovered, their Chinese government scholarships will be

cancelled, and they are required to return the Chinese government scholarships they

have already received. For those who deliberately conceal their financial support, they

will not be allowed to apply for Chinese Government Scholarships for three years, in

addition to being disqualified.

Within the same admission year, each applicant is limited to submitting one

application for Category B. Applicants for Category B scholarships who have more

than one preferred institution should decide on one as the scholarship applicant's

preferred institution, and the submitted application for Category B will be regarded as

the applicant's final preferred institution.

The research plan submitted by the applicant will be regarded as the most

important basis for the final review stage by the China Scholarship Council.

In principle, applicants are not allowed to change their majors after admission.
